Notice of meeting to discuss potential rezoning of 13 noncontiguous parcels located generally along the periphery of Duke's campus containing approximately 25 acres and having Durham County Parcel Identification Numbers 103330; 103334; 104550; 104553; 104567; 108811; 108816; 113384;

113385; 113388; 113540; 113586; & 197975 (the "Property").

We are counsel for Duke University ("Duke") which is seeking to rezone the abovereferenced Property to University and College (UC) district. We previously held a neighborhood meeting on June 30, 2021, to discuss the rezoning. Since then, our team has met with area stakeholders regarding the rezoning. We are close to submitting the rezoning and are holding a second neighborhood meeting to discuss the rezoning application.


As was the case before, Duke has no specific plans for development on the Property and is seeking the rezoning to facilitate planning the future of its campus. The Property being considered for rezoning is highlighted in red on the context map included with this mailing. You may notice that a few of the parcels we previously considered rezoning have been removed from the applications. Nevertheless, we have attempted to mail this notice to the owners and occupants of properties within 600-ft of the original rezoning request.

We will hold a virtual neighborhood meeting on Tuesday, June 28, 2022, from 6:00 P.M. to 7:00 P.M. via Zoom. The purpose of the neighborhood meeting is to ensure that nearby property owners are made aware of the proposed rezoning and have an opportunity to ask questions and share comments with us. This feedback will help us understand how this rezoning could impact you.

Instructions for registering for and joining the meeting are enclosed.
